

**CORPORATION OF THE TOWN OF RENFREW**  
**BY-LAW NO. 83-2016**

Being a by-law to amend By-Law No. 29-98, as amended, to provide for the naming and renaming of the highways, streets, roads and private roads within the Town of Renfrew.

WHEREAS Section 27 of the *Municipal Act*, S.O. 2001, c.25, as amended, establishes that a municipality may pass by-laws in respect to highways only if it has jurisdiction over the highway; and

WHEREAS the Corporation of the Town of Renfrew, is desirous to name this portion of public highway.

NOW THEREFORE the Council of the Corporation of the Town of Renfrew enacts as follows:

- 1) THAT this by-law may be cited as being "Amendment No. 4" to the Road Naming By-Law of the Corporation of the Town of Renfrew and that the following is hereby adopted:





- 2) THAT the portion of public highway named Health Village Lane shall be that as described as being Part 5 of Registered Reference Plan 49R-11502.
- 3) THAT the municipality is hereby authorized to affix street name signs at the corners of every highway, street, road and private road, on public or private property, subject to the jurisdictions and the requirements of the County or the Ministry of Transportation.
- 4) THAT all road name signs at intersections shall include the approved road name. Where new signs are to be erected, the sign shall include the approved road name and the direction and sequencing of property numbering.
- 5) THAT should any section, clause or provision in this By-Law hold to be invalid by a court of competent jurisdiction, the remainder of this By-Law shall not be affected.
- 6) THAT any By-Law or parts of By-Laws inconsistent with this By-Law, or names of streets in registered plans inconsistent with this By-Law, are hereby deemed repealed.
- 7) THAT the unopened road allowance shown as Parts 5 on Registered Reference Plan 49R-11502, Town of Renfrew, County of Renfrew, and be designated as public highway under the Municipal Act, 2001, S.O. 2001, c.25, s.31(1).
- 8) THAT this By-Law shall come into full force and effect when a copy of it, certified under the hand of the Clerk and the seal of the Corporation, has been registered in the proper land Registry Office.
